**Transportation Development Act Claims: City of Elk Grove, City of Galt, County of Yolo, County of Yuba, Sacramento Regional Transit District, Yolo County Transportation District, Yuba-Sutter Transit District, and Paratransit, Inc.**

**Issue:** The Transportation Development Act provides that cities, counties, and transit operators are eligible to receive certain funds for transportation purposes and street and road projects. The funds are made available from sales tax receipts. Transportation Development Act claims have been submitted by the City of Elk Grove, City of Galt, County of Yolo, County of Yuba, Sacramento Regional Transit District, Yolo County Transportation District, Yuba-Sutter Transit District, and Paratransit, Inc.
