SACOG Guidelines and Applications for Distribution of Proposition 1B Transit System Safety, Security, and Disaster Response Account – Bond Funds

Issue: Proposition 1B Transit Safety, Security and Disaster Response Account (TSS) Bond Funds are available for the 2008-2009 cycle. The Department of Homeland Security has set January 21, 2009, as the due date for applications, although action may be delayed due to the unresolved state budget. SACOG has received applications for projects to be funded through the “regional” funding account.

Recommendation: That the Strategic Planning Committee recommend that the Board adopt the attached resolution and project recommendations and authorize staff to submit applications for the TSS Account for projects submitted by transit operators under the regional funding program.

Discussion: The adopted state budget makes funds available in FY 2008-2009 through Proposition 1B under the TSS Account totaling \$60 million statewide, pending resolution of current budget issues and the reopening of state bond funds. For the SACOG region, a total of \$2,158,763 million is available; \$1,398,859 comes through SACOG as the Regional Transportation Planning Agency (RTPA), and an additional \$759,904 goes directly to the region’s transit operators. TSS Account funds are allocated to regions and transit operators on the same formula used for the allocation of State Transit Assistance funds. TSS Account funds also flow to the Placer and El Dorado RTPAs and transit operators in those counties separately from SACOG.

Project applications have been received from the Sacramento Regional Transit District, Paratransit Inc, the City of Elk Grove, the Yolo County Transportation District, and the Yuba-Sutter Transit Authority. SACOG staff has reviewed the applications—using guidelines approved by the SACOG Board in April 2008—with the Transit Coordinating Committee (TCC) at its December 17, 2008, meeting and prepared the attached final project funding recommendations. The full amount available of regional funds has been recommended by the Transit Coordinating Committee. Recommended funding levels were based upon scoring of applications using the SACOG approved guidelines.

The Proposition 1B funds available for FY 2008-2009 are outlined in the table above. The program is for ten years and the next application cycle is due on January 21, 2010. Sixty million dollars per year for ten years is expected to be available to be allocated across the state.

For FY 2008-2009, approved projects must be completed by March 31, 2012. Additionally, grant recipients must submit biannual performance reports as outlined on page 20 of the CTSGP-CTAF Guidelines. The reports are submitted using the Office of Domestic Preparedness Secure (FEMA) Portal at: <https://preparednessportal.dhs.gov/>. Directions on registering for the Secure Portal can be found on Page 14 of the CTSGP-CTAF Guidelines.

The SACOG Project Evaluation Form will be used to score potential projects for final selection. All projects in 99313 must be applied for through SACOG. SACOG will then score the 99313 applications and notify applicants of their status. For 99314 applicants, they do not need to complete the SACOG Project Evaluation Form. However, 99313 funds applied for must complete an Investment Justification from the CTSGP-CTAF Guidelines and submit the Investment Justification to SACOG by December 8, 2008 by the close of Business.

The applications are due to SACOG on December 8, 2008 by the close of business. SACOG will then review the 99313 applications and score the applications. The applications will be forwarded to the Office of Homeland Security by highest score until all of the funds allocated in the County under 99313 are accounted for. For projects that do not score high enough, SACOG will notify the applicant.
