### **SACOG Funding of Transit Projects Using Proposition 1B Transit—Public Transportation Modernization, Improvement, and Service Enhancement Account (PTMISEA) Funds**

**Issue:** Approval to submit a Public Transportation Modernization, Improvement, and Service Enhancement Account (PTMISEA) Grant Application to Caltrans Division of Mass Transportation.

**Recommendation:** That the Transportation Committee recommend that the Board approve by resolution and authorize staff to submit a grant application to Caltrans Division of Mass Transportation for the project submitted by the City of Elk Grove in response to the June 15 PTMISEA FY 2009/10 Cycle I call for projects. That the Committee also recommend that the Board authorize the Executive Director to enter into a subrecipient agreement with the City of Elk Grove for the funding once it is approved by Caltrans.

**Discussion:** The FY 2009/10 California State Budget includes \$350 million in funding for PTMISEA, which is the same funding level as FY 2008/09. The State Controller's Office has yet to announce apportionments for FY 2009/10, but the FY 2008/09 apportionment for SACOG was \$7,878,327. Caltrans Division of Mass Transportation has stated they expect the grant application schedule to remain the same as previous years (i.e., September 30 and April 15). Based on the expected schedule and SACOG's guidelines, staff issued a call for projects on June 15, with submittal due dates of August 4 and March 2. SACOG received one project request for \$800,000 to upgrade automated fare boxes for the City of Elk Grove. No other project requests were submitted as part of this cycle.

The SACOG's process for PTMISEA funding also includes a recommendation from the Transit Coordinating Committee (TCC). This item will be reviewed by the TCC at its September 9 meeting. TCC action will be included in the staff report to the Board of Directors.

Available state funding has trailed the apportionments as the State of California sells bonds to finance its projects. Staff has not submitted the subrecipient funding agreements with the project sponsors until SACOG has received the funds from the state. Currently, the state is anticipating a bond sale which will fund FY 2008/09 Cycle II projects, including three SACOG projects totaling \$6,664,000. It is not known when funds will be available for FY 2009/10 Cycle I projects.

With Board approval, staff will submit the City of Elk Grove's grant application for \$800,000 for the Automated Farebox Upgrade project. This action also includes an authorizing resolution with the application and a subrecipient funding agreement when the funds are received by SACOG.
