The SACOG Government Relations & Public Affairs Committee met on April 10, 2017 in the Sacramento & American Rivers rooms on the Third Floor of the Meridian Plaza Building located at 1415 L Street, Sacramento, CA at 10:00 a.m.

<u>CALL TO ORDER</u>: Vice Chair Kennedy called the meeting to order at 10:00 a.m.

10. SB 375 Greenhouse Gas Emissions Reduction Target Setting

The Committee received and reviewed this report, presented by Mr. Bruce Griesenbeck, SACOG Staff. Director Stallard asked staff to clarify the relationship of SACOG with the jurisdictions in achieving AB 32 goals. Director Stallard asked staff if there's any coordination. Staff explained that there is a fair amount of coordination. Director Samayoa stated to staff that the City of Marysville would like to be involved in the Innovation with this project. Director Onderko stated to staff he'd like to hear more from the private industry in setting targets.

11. May is Bike Month 2016 Recap and 2017 Campaign Update

The Committee received and reviewed this report, presented by Ms. Sabrina Bradbury, SACOG Staff. Director Stallard asked staff if we were losing participants in the campaign each year and if so, what's being done about that. Ms. Bradbury commented they would like to collect more data on that. Director Stallard suggested there be a way to keep people biking long term and that there's a need for an appointed Bicycle Advocate/Activist in his jurisdiction.

12. Federal Policy Update

13. State Advocacy Update
