### Cap-to-Cap 2015

**Issue:** Report on Metro Chamber Annual Cap-to-Cap Program.

**Recommendation:** This is an information only item. There will not be a staff presentation.

**Discussion:** SACOG staff and Board leadership will be participating in the Metro Chamber Annual Cap-to-Cap Program April 18-22. SACOG Board members are encouraged to participate in individual policy team meetings in February, March and April. The Transportation Team is being co-chaired by Erik Johnson from SACOG and Cheryl Creson from Parsons Brinckerhoff. SACOG staff will update the list of Cap-to-Cap Teams and their volunteer leadership as new information is available.

SACOG staff is currently working with the Chamber's policy teams to provide input on issue papers for several teams that intersect with SACOG's work, including: Air Quality, Land Use and Natural Resources, Flood Protection, Water Resources, Transportation, Food and Agriculture, Community Development, and Civic Amenities. The Metro Chamber Transportation Committee will meet February 10, March 10, and April 14 at 9:00 a.m. to discuss Cap-to-Cap and other transportation issues in the region. Final issue papers are approved by the Metro Chamber Board.

SACOG staff will attend Cap-to-Cap and is available to support SACOG Board members in policy teams and advocacy meetings. Staff will provide an update on Cap-to-Cap preparations at the March committee meetings.
