**SACOG Board of Directors**

**Adopt SACOG Board of Directors and Committee Schedule for 2013**

**Issue:** Adoption of the SACOG Board of Directors and Committee meeting schedule for the 2013 calendar year.

**Recommendation:** The Government Relations & Public Affairs Committee recommends that the SACOG Board of Directors adopt the Resolution 58-2012 adopting the SACOG Board and Committee schedule for calendar year 2013.

**Committee Action/Discussion:** The SACOG Board of Directors must adopt its Board and Committee meeting schedule for the following year prior to the beginning of the calendar year.

The Metro Chamber's Cap-to-Cap is scheduled for April 13-17, 2013. The Board meeting would normally be scheduled for the following day, April 18. Staff recommends that the April 18 Board meeting be moved to April 25. The League of California Cities' Annual Meeting is scheduled for September 18-20, 2013. The Board meeting would normally be scheduled for September 19. Staff recommends that the September Board meeting be scheduled for September 26. Also CSAC will be holding their annual meeting on November 19-22. The following Thursday is the Thanksgiving holiday. Rather than move the date up to November 7, which is only three weeks after the normally scheduled October board meeting, staff recommends combining the October and November board meetings and hold one meeting on November 14, with the committee meetings being scheduled for October 31 and November 4. The Board will be in recess during the month of July. The attached schedule reflects the recommended schedule changes as noted above.

The schedule assumes that the Committee structure remains as it currently exists; however, it is the discretion of the 2013 Chair to amend the Committee structure. Should the 2013 Chair choose to amend the Committee structure, the schedule would be changed accordingly. It is also the 2013 Chair's prerogative to add or cancel meetings to address the needs of SACOG. The final schedule and committee assignments will be distributed in late January 2013.
