### 2015 SACOG Delivery Plan Update

**Issue:** What were the results of regional project delivery in 2015?

**Recommendation:** None, this is for information only.

**Discussion:** Each year, SACOG helps project sponsors deliver their projects with SACOG-controlled federal funds from the Congestion Mitigation and Air Quality (CMAQ) program, Regional Surface Transportation Program (RSTP), and Regional Improvement Program (RIP or “STIP”). Delivering a transportation project through the federal aid funding system can be a timely and cumbersome process. SACOG’s staff and the annual “Delivery Plan Process” help simplify and shorten that process by assisting project sponsors with delivery timing, utilization of prioritization tiers, and implementation of general best practices. The approach to the Delivery Plan Process is annually adopted at the beginning of each federal fiscal year.

Project sponsors and Caltrans Local Assistance staff have been working hard this past year to authorize projects. In 2015, SACOG helped our region’s agencies deliver a projected \$50,199,546. Based upon this projection, our region exceeded the Obligation Authority (OA) target of \$33,599,275, and went into negative OA by \$16,600,271. As a result of exceeding our target, SACOG will likely win additional OA for SACOG through the “August Redistribution” process, which is the federal reallocation of leftover OA from the rest of the country. Caltrans has not yet announced how much SACOG will receive. Last year SACOG over-delivered by \$17 million and garnered \$4.2 million of OA from the August Redistribution. How much SACOG will receive this year depends on a number of factors, including state use of OA, other regional organizations’ use of OA, and proportion of use.

Attachment A lists all 36 projects that had a net positive obligation this year based upon available information. Additionally, SACOG has continued to create opportunities for projects to advance through its tiered prioritization process. This year the City of West Sacramento utilized a Tier III loan of \$2,400,000 of RSTP funds to advance its project, the Pioneer Bluff Bridge Phase 2 – Village Parkway Extension, from the STIP where it was programmed in a later year. As a result, the City was able to start construction in 2015, just two years after receiving funding from the SACOG Regional/Local Program, and five years earlier than waiting for a STIP allocation.
