### Metropolitan Transportation Plan/Sustainable Communities Outreach Update/Elected Officials Meetings

**Recommendation:** None, this is for information only.

**Discussion:** Throughout February, in accordance with Senate Bill 375, SACOG will host an elected official meeting in each county of the SACOG region. These meetings are targeted to the full membership of city councils and county boards of supervisors, city managers, county administrators, and jurisdiction staff working on the 2016 Metropolitan Transportation Plan/Sustainable Communities Strategy (MTP/SCS). The meeting is designed to provide city and county elected officials who may not sit on the SACOG Board ample opportunity to provide input on the MTP/SCS, and gain better understanding of how the MTP/SCS builds off of existing local plans (e.g., capital improvements programs and general plans).

Staff has provided notice via city and county clerks of the boards to aid in dissemination of the meeting information. Additionally, this information was provided at the Regional Managers meeting on January 20, and the Planners Committee/Regional Planning Partnership joint meeting on January 28. Local planning staff also received the meeting details with the e-mail packet on the discussion draft preferred scenario for the MTP/SCS on January 26. Attachment A is the schedule of all the elected official meetings.

On February 6, staff will hold a meeting of the MTP/SCS stakeholder Sounding Board. The Sounding Board was developed at the direction of the SACOG Board in 2013. The purpose of the Sounding Board is to provide input and feedback to staff and the SACOG Board throughout the development of the MTP/SCS. The Sounding Board has met quarterly since October 2013. Staff will provide a summary of the February meeting during the March Board committee cycle.
