The California Department of Transportation has completed the review of the following amendment to the Sacramento Area Council of Governments' (SACOG) 2019 Federal Transportation Improvement Program (FTIP):

<u>No.</u>	<u>Description</u>
11	Local, State and Transit Transportation Systems

- This amendment modifies and adds projects in the Sacramento Area funded from the Active Transportation Program, Congestion Mitigation and Air Quality Improvement Program, Earmark Repurposed Funds, Highway Bridge Program, Highway Infrastructure Program, High Priority Program, Highway Safety Improvement Program, State Highway Operation and Protection Program, State Transportation Improvement Program, Surface Transportation Block Grant Program and Federal Transit Administration (FTA) Section 5309 Program. It also adds performance measure language to support SACOG's targets for Bridge and Pavement Conditions (PM2) and System Performance, Freight, and Air Quality (PM3).

The SACOG Letter adopting this FTIP amendment confirms that it is financially constrained, meets requirements of public involvement procedures adopted by SACOG and all applicable transportation planning requirements per Title 23 Code of Federal Regulations Part 450.
